If approved by the Board of Directors, your matter will be added to the agenda, and you will be provided an opportunity to address the Board. This does not apply to those who are appealing a fine for a violation under Chapter 209 of Texas Property Code. Those who request a hearing under Chapter 209 within the time frame allowed, will be automatically granted time during the meeting.
