## FIRST AMENDMENT TO THE BYLAWS OF OAKWOOD TOWNHOMES HOMEOWNER'S ASSOCIATION, INC.

This First Amendment to the Bylaws of Oakwood Townhomes Homeowner's Association, Inc. (the "Amendment") is made by Oakwood Townhomes Homeowner's Association, Inc., a Texas limited liability company.

#### RECITALS:

Section 3.05 Quorum: A majority of the voting shares constitutes a quorum for the transaction of business. Business may be continued after withdrawal of enough Members to leave less than a quorum.

NOW THEREFORE, the Bylaws, are hereby amended and modified as follows:

#### Section 3.05 Quorum:

Except as otherwise specifically provided in the Declaration or the Certificate of Formation, the presence, either in person, by proxy, by absentee ballot, or by electronic ballot, at any meeting of the Members entitled to cast at least ten percent (10%) of the total voting power of the Association will constitute a quorum for any action; however, an absentee or electronic ballot may be counted as a Member present and voting for the purpose of establishing a quorum only for items appearing on the ballot. In absence of a quorum at a meeting of Members, a majority of those present in person or by proxy may adjourn the meeting to a time not more than forty-eight (48) hours from the time the meeting was called, and for additional forty-eight (48) hour periods until a quorum is present.
